

### PRIVACY DISCLAIMER

In compliance with the obligations deriving from the community legislation (European Regulation 2016/679, GDPR) and subsequent amendments, this site respects and protects the privacy of visitors and users, putting in place every possible and proportionate effort not to infringe the rights of users. This privacy policy applies exclusively to the online activities of this site and is valid for visitors / users of the site. However, it does not apply to information collected through channels other than this website. The purpose of the privacy information is to provide maximum transparency regarding the information that the site collects and how it uses it.

### LEGAL BASIS OF THE TREATMENT

This site processes data based on consent. With the use or consultation of this site, visitors and users explicitly approve this privacy statement and consent to the processing of their personal data in relation to the methods and purposes described below, including any disclosure to third parties necessary for the delivery of a service. The provision of data and therefore the consent to the collection and processing of data is optional; the User can refuse consent, and can revoke a consent already given at any time (via the Contact link at the bottom of the page).

### COLLECTED DATA AND PURPOSES

Like all websites, this site also makes use of log files in which information collected automatically is stored during user visits. The information collected could be the following: Internet protocol (IP) address; type of browser and device parameters used to connect to the site; Name of the internet service provider (ISP); Date and time of the visit; Web page of origin of the visitor (referral) and exit; Possibly the number of clicks. The aforementioned information is processed in an automated form and collected in an exclusively aggregated and pseudonymised form in order to verify the correct functioning of the site and for security reasons; this information will be processed according to the legitimate interests of the owner. For security purposes (spam filters, firewalls, virus detection), the automatically recorded data may possibly also include personal data such as the IP address, which could be used, in accordance with applicable laws, in order to block attempts to damage the site itself or to cause damage to other users, or in any case harmful activities or constituting a crime. ### PLACE OF TREATMENT

The data collected by the site is processed by the Data Controller located in Via Maggiore, 14 – Premariacco 33040 – (UD), and is only handled by technical personnel authorised to process the data, or by any persons in charge of occasional maintenance operations.

### TRANSFER OF DATA TO NON-EU COUNTRIES

This site may share some of the data collected with services located outside the area of the European Union. The transfer is authorised based on specific decisions of the European Union and of the Guarantor for the protection of personal data, in particular the decision 1250/2016 (Privacy shield), for which no further consent is required.

### SECURITY MEASURES

This site processes user data in a lawful and correct manner, adopting appropriate security measures to prevent unauthorised access, disclosure, modification or unauthorised destruction of data. The treatment is carried out using IT and / or telematic tools, with organisational methods and with logic strictly related to the purposes indicated. In addition to the owner, in some cases, categories of agents involved in the organisation of the site (administrative, commercial, marketing, legal, system administrators) or external subjects (such as third party technical service providers, postal couriers, may have access to the data). hosting provides, IT companies, communication agencies).

### INFORMATION ON COOKIES

The "cookie" is a simple text file that is downloaded from your computer (or any other device used to navigate) to store information related to the navigation of a particular site. Cookies are downloaded from the web server that hosts the site and downloaded from the browsers (Internet Explorer, Mozilla Firefox, Google Chrome, etc ...) used by the end user, these files therefore reside in the user's device and are used / read during the subsequent visits to the site.

### TYPES OF COOKIES

#### TECHNICAL COOKIES

This type of cookie allows certain sections of the site to function properly. ### THIRD PARTY COOKIES

#### PROFILING COOKIES

#### BLOCK COOKIES
